

NRPIA Board Meeting | Jan 3, 2023

- Approved minutes from Sep 28 2022
- Treasurer update (Donna)
 - Checking account balance: \$8,052.81
 - Savings account balance: \$13,645.22
 - Corp reinstatement in process
 - [Action Item] Donna to file 2022 Tax Return
- NorthRolandPark.org website updates (John)
 - Newsletter to driver w/articles from [news](#) page to promote the website and invite people to join & participate. (funnels to northrolandpark@gmail.com)
 - John Proposed creating a newsletter every 3-6 months to illustrate what we're doing for the neighborhood with articles from [news](#) page to promote the website and invite people to join & participate.
 - [Action Item] Promote finished website on NextDoor as well.
- Annual Dues notice will go out this month: [Dan]
 - [Action Item] Dan & John will bundle dues request with a Q1 newsletter
 - Include: News articles from website, Highlight what the dues pay for including advocacy, Update on the crime incident from the summer.
 - Direct people to the website to make payment (now includes Square)
- [Operation Pipeline](#) Gas line repairs & issues [Ricci]
 - Natural gas leak(s) reported by NRPIA and addressed by BGE.
 - Riggs Distler is the contractor for BGE doing retrenching.
 - Learned that road crews are not replacing gas lines at this time, they are laying new piping for it to be dug up and the gas lines will be connected together and turned on.
 - This will continue through June 2023, then the lines will go live and repaving will happen.
 - Looped in Yitzy's office to increase urgency and address poor road work quality. We now have a POC from BGE to call for any really bad work (sink holes, etc).
 - Open question: Who is doing the repaving once all gas lines are replaced?
- Public Safety & Northern District [Ricci]
 - Attended 12.14 Commanders Meeting; shared notes w/community.
 - 13 homicides in district, same as 2021. Commercial robberies and carjacking are up.
 - 9 crimes in NRP in Q4, most happen on Falls Road. One burglary on St. Georges, another on Poplar Hill. All were property theft/burglary.
 - Treat drop off for Northern District: delayed, but Ricci will handle (40 ppl, Bagels).
- Melrose Ave bridge project [Doug]
 - Working on getting insurance for the Friends of Melrose Bridge entity; Hoping to resolve early Spring 2023.
 - Then we'll move to pricing; if there's a gap relative to the grant we received we'll do a capital campaign: neighborhood, Orchards, schools, etc.
- Falls Road / Northern Parkway intersection changes: CIP meeting [Ricci]
 - CIP Process: Capital Improvement Program - the city's Capital Budget
 - The document is a wishlist, not a funding commitment.
- The Falls / Assisted Living [Doug]
 - Lawsuit continues on whether the project can proceed. Zoning board has not ruled yet.
